The University of St. Thomas, in cooperation with the UST Police Department is pleased to arrange and offer a special **Celt Tailgating Experience**. The experience requires advance reservations and will be located at predetermined locations. Tailgating will be allowed only in the designated areas. Other locations in and around the campus will not be permitted.

## TAILGATING RULES AND REGULATIONS:

- Tailgating will be located in designed areas on the campus of University of St. Thomas (*see map*), which includes parking. Tailgater must submit payment along with the signed disclaimer before being allowed to enter.
- A Standard Tailgating area is 10' x 10' (*see map for areas*)
- An Extended Tailgating area is 20' x 20' (*see map for areas*)
- Tailgaters can use charcoal and propane grills in the tailgating area only, **no open flames**. (UST personnel can refuse any grill that does not meet standards set by the Office of Facilities).
- Possession and consumption of alcohol on the property of the University of St. Thomas, including its buildings, facilities, grounds and parking areas is subject to the laws and regulations of the State of Texas and TABC. Subject to applicable law and University policy alcohol consumption is permitted only in the official tailgate areas.
- Tailgaters cannot sell or distribute alcoholic beverages.
- No overnight Tailgating. Operating hours are 7:00 am – 8:00 pm
- Homecoming Tailgating load-in gates open at 7:00 am and closes at 9:00 am on dates.
- All vehicles must exit by 9:00 am.
- No vehicles permitted in tailgating area after load-in closes.
- Patrons failing to arrive during designated time will have to carry all items to their designated area.
- Pets are not allowed to run freely in the tailgate areas, they must be on a controlled leash. Animals shall not be left unattended or secured to University property.
- Pet owners are solely responsible for their pets and any damage or injuries that may occur. You must clean up after your pet.
- Ill-behaved pets or ones deemed dangerous, intimidating or destructive will be evicted and banned from University property.
- In the case of inclement weather, University of St. Thomas personnel reserve the right to cancel or discontinue the **Celt Tailgating Experience**.
